

AASECT Sex Therapist Supervisor Certification Application

Applicants will be evaluated on the basis of the requirements for AASECT Certified Sex Therapist Supervisor in effect as of January 1, 2015. Only those members whose application information and documentation meet those requirements are eligible for certification. Please read the instructions carefully and include all required documentation. Applicant must submit:

- Documentation of current AASECT Membership.
- Documentation of initial date of AASECT Sex Therapist Certification by including a copy of your current Certification Certificate. Applicant must be certified by AASECT as a Sex Therapist for a minimum of three (3) years prior to starting supervision.
- Current curriculum vitae (CV)
- Documentation of a minimum of thirty (30) hours of “supervision of supervision” of sex therapist(s) from an AASECT Certified Sex Therapist Supervisor. Applicants must also include a copy of their supervision contract(s) along with all of the supporting documents as stated on the website page, “Supervision Guidelines,” <https://www.aasect.org/guidelines-supervision>.
- Written summary of the applicant's supervision of at least one sex therapist supervisee, including the applicant's supervisory style and the utilization of concepts deemed appropriate to the specific case. The summary should focus on the supervision process provided by the supervisor-in-training.
- Written endorsements/letters of recommendation from two (2) professional colleagues, in addition to the endorsement from the AASECT Certified Sex Therapist Supervisor who are able to evaluate the applicant's fitness for designation as an AASECT Certified Sex Therapist Supervisor.
- Non-refundable application fee of \$300.00.
